

CUSTOMER / SUPPLIER / BUSINESS PARTNERS INFORMATION NOTICE

In accordance with the Law on the Protection of Personal Data No. 6698 (“Law”), your personal data may be processed by Ege Kimya San. ve Tic. A.Ş. (“Company”), as the data controller, within the scope explained below.

Purposes of Processing Personal Data

Our Company processes your personal data for the following purposes, limited to and proportionate with these purposes:

- Management of production and operational processes of products and services,
- Provision of products and services, execution of sales/purchasing processes,
- Tracking and management of requests and complaints,
- Monitoring of contractual processes and legal claims,
- Execution of corporate communication activities.

Transfer of Processed Personal Data to Whom and for What Purpose

Your personal data, for the purposes stated above, may be transferred to legally authorized public institutions and organizations, and authorized private persons, upon proper request, within the conditions set forth in Articles 8 and 9 of the Law.

Due to the servers of Microsoft applications used within the Company being located abroad, your personal data may be transferred abroad with appropriate safeguards and by taking necessary technical and administrative measures. Some of your personal data may also be transferred to our group companies, due to the use of shared departments and operational requirements.

Additionally, within the scope of export processes, your personal data may be transferred to relevant parties abroad, limited to cases where it is mandatory for the fulfillment of contractual obligations. In such transfers, necessary technical and administrative measures are taken in accordance with the applicable legislation, and the transfer is carried out only to the extent required for the performance of the contract.

Method and Legal Grounds for Collecting Personal Data

Your personal data is collected within the scope of benefiting from the services we provide, through channels where you contact us physically (face-to-face) or electronically. The legal grounds include: explicit stipulation in laws, necessity for the establishment or performance of a contract, necessity for the Company to fulfill its legal obligations, and processing being mandatory for the legitimate interests of the Company.

Rights of the Data Subject under Article 11 of the Law

As the data subject, you have the following rights under Article 11 of the Law:

- To learn whether your personal data is being processed,

- To request information if your personal data has been processed,
- To learn the purpose of processing and whether it is used in accordance with its purpose,
- To know the third parties to whom your personal data is transferred domestically or abroad,
- To request correction if your personal data is incomplete or incorrectly processed, and to request notification of such correction to third parties to whom the data has been transferred,
- To request deletion or destruction of your personal data if the reasons requiring its processing cease to exist, and to request notification of such deletion or destruction to third parties to whom the data has been transferred,
- To object to the occurrence of a result against you through the exclusive analysis of processed personal data by automated systems,
- To request compensation if you suffer damage due to unlawful processing of your personal data.

You may submit your applications regarding these rights to our Company through the methods specified in the Application Form available on our Company's website.

Depending on the nature of your request, your applications will be finalized free of charge as soon as possible and within thirty days at the latest. However, if the process requires an additional cost, a fee may be charged according to the tariff determined by the Personal Data Protection Board.
